Roberta C. Pike, an attorney duly admitted to practice in the courts of the State of New York,
does hereby affirm the following statements to be true under the penalty of perjury:

1. I am a partner in the law firm of Pike & Pike, P.C. (“Pike & Pike”), counsel to
petitioner Citywide Corporate Transportation, Inc. (the “Corporation”) in the within proceeding
pursuant to N.Y. Bus. Corp. Law § 1102.

2. This Supplemental Affirmation is submitted in further support of the Corporation’s
application for leave to distribute certain remaining assets of the Corporation, and thereafter dissolve
the Corporation.

3. Specifically, this Supplemental Affirmation is submitted for the limited purpose of
updating certain monetary figures set forth in my Affirmation dated August 5, 2016.

4. On August 12, 2016 (the day after the within Order to Show Cause was presented to
and signed by the Court), my office received a telephone call from Rubbe Cesar (“Cesar”), a
shareholder of the Corporation. Cesar stated that he had moved approximately two years ago, and

realized after having not received any updates about this proceeding for quite a while that he had never provided us with his new address and telephone number.

5. I subsequently determined that the \$200.00 check issued to Cesar in connection with the prior distribution had not been cashed, following which a stop payment order on the uncashed check was placed, and new check was issued to him. A redacted copy of the check is annexed hereto as Exhibit "N."


6. In light of the foregoing, the two figures reported in paragraph "22" of my prior Affirmation dated August 5, 2016 (i.e. the escrow balance, and the value of the uncashed distribution checks) should each be debited by \$200.00.

7. For the reasons set forth in my prior Affirmation, I respectfully ask that the relief prayed for in the Corporation's Order to Show Cause be granted in all respects.




